1. INTRODUCTION

All SAAACA members and non-members are welcome to rent a trade table or outdoor space. Showcase and sell your items at a trade table or set up an association gazebo or military/arms display outside.

Participation also helps maintain your annual good standing as a registered collector.

2. TRADER RULES

Trading at the Arms Fair is subject to the conditions hereunder:

1. Cost per table per day is as follows :

SAAACA Members R220 per table *

Non SAAACA Members R280 per table *

The trading table fee includes entry for two people for the full duration of the fair, regardless of whether you attend for one or both days.

Additional helpers will need to pay the standard entrance fee at the Museum.

2. Payment must be made to the SAAACA bank account and received by the SAAACA office before the Arms Fair.

We are unable to accommodate late bookings and payments during the event.

3. Trading is subject to the Museum rules.

Traders may request a specific space or position, subject to availability.

Please note that the Vehicle Hall and the Ward Shop will not be available this year.

4. Exclusive parking is available for traders but is entirely at your own risk. The Museum, SAAACA, and their staff will not be held responsible for any loss, damage, or theft that may occur while parking on the premises.
